Sub: Preventive measures to be undertaken to contain the spread of COVID-19 by RITES Ltd.

In pursuance of Office Memorandum issued by DPE vide its OM dated 22nd March, 2020, in further reference to DOPT circular OM No.11013/9/2014-Estt(A-III) dated 22nd March,2020 the following directions are hereby issued for further compliance of Division/Project Office/Regional Office/REMCL.

- SBU Head of respective Regional Office/Project Office, RITES Ltd, REMCL may draw up a roaster of staff including those of consultants, contractual employees and outsourced employees working under them who are required to work in the office considering the urgency and fulfilling the basic requirement of functions of the Office. Only those employees who are required to perform the essential duties may be asked to attend the office.
- In other words only skeleton staff will be asked to attend the office from 23rd March Until 31st March, 2020.
- The officials who are working from home should be available on telephone and electronic means of communication at all times. They should office if called for, in case of any exigencies of work.
- Concerned Officials of CMD and Directors office are requested to take measures to perform work form home facilities.
- These instruction shall not apply to the officers and employees engaged in essential/emergency services and those directly engaged in taking measures to control spread of COVID 19.
- vi) These instructions shall be applicable with immediate effect.
